Dear friends,

This management report of the Fundación Andina, for the year 2023, covers the period from January to December and presents the achievements in environmental management and sustainable development in the Andean and Pacific regions of Colombia. Throughout the year, our initiatives have driven significant transformations, generating positive impacts on both ecosystems and the well-being of local communities. In the face of a challenging outlook, we reaffirm our commitment to prioritize the preservation of life in all its forms.

With 15 years of experience, the Fundación Andina has consolidated its presence in the Andean and Pacific territories, promoting strategies for the conservation of biodiversity, gender equity and sustainable development. Our work has been oriented towards generating opportunities in various communities, responding not only to the urgency of mitigating environmental problems, but also to the potential that each territory offers to strengthen sustainability and responsible management of natural resources.

Deforestation remains one of the main environmental threats in the country, triggering climate variations, loss of biodiversity and a reduction in ecosystem services essential for food security, climate stability and social progress. However, due to the socio-ecological particularities of each region, its effects manifest themselves with different intensity and pose different challenges. For this reason, it is essential to address each context with strategies adapted to its specific needs.

Throughout 2023, the Andina Foundation carried out more than 25 projects, focused on environmental education, empowerment of rural and indigenous communities, ecological restoration, promotion of renewable energies and strengthening female leadership in territorial management. These initiatives have covered various lines of action, such as support for community projects, formalization of alliances with academic institutions for the training of indigenous leaders, rehabilitation of degraded ecosystems, creation of protected areas and implementation of circular economy models.




